FUND COMMENTARY

The US reporting season is in full swing. Almost half of the S&P 500 index constituents have already reported. Since we invest for long term sustainable growth in outstanding businesses, we do not 'live from one reporting season to the next' in our decision making. It is, though, valuable to understand the macro earnings backdrop because of its influence on overall investor sentiment.

The S&P 500 earnings in aggregate are currently 36% higher than their peak level before the credit crisis (186% higher than their trough level during the credit crisis, \$ terms). This implies a +3.0% p.a. compounded growth rate since the peak, probably lower than many investor perceptions (+13.8% p.a. since the trough). Earnings growth stagnated from the beginning of 2015 as the Dollar strengthened and economic growth tempered, and only started growing again from the middle of last year.

The outlook for US company earnings (twelve month forward expectations) improved materially through 2017 and ended at +13.2% (current actual earnings growth has accelerated to +11.4%). This constructive development results mainly from a weaker Dollar and an improving economic landscape. The current synchronised global economic growth, good recovery in industrial production in most economic regions and growth in world trade clearly support company earnings growth not only in the US, but in most parts of the world.

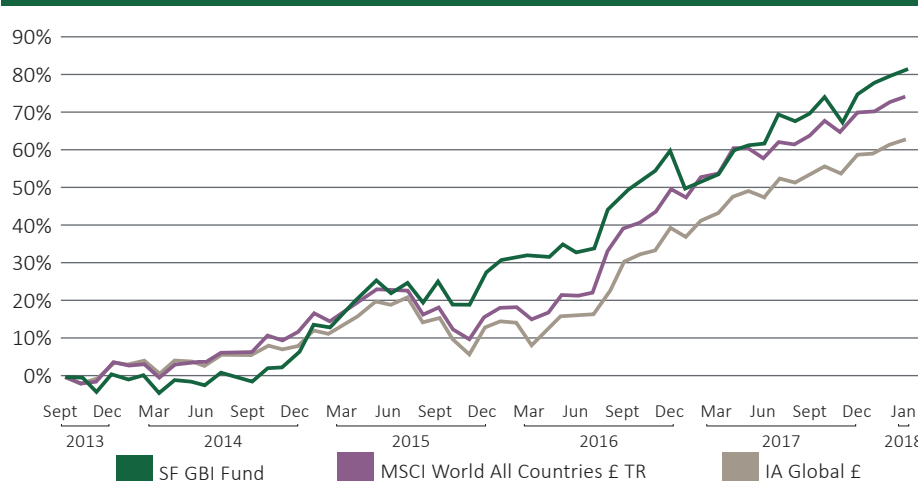
The above numbers do not reflect the benefits of the US tax reforms which are only now starting to reflect in consensus analyst earnings expectations. During the course of January the aforementioned +13.2% growth has already increased to an expectation of +19.0%. Should this growth materialise, it may be of the best growth figures this century (apart from the recoveries in 2010/11 after the credit crisis earnings slump).

Expectations on this front are clearly high. The current reporting season is delivering well (actual earnings growth of +14.7%, +4.2% better than consensus expectations).
