FUND COMMENTARY

Calendar year 2018 ended on a disappointing note with the MSCI AC World index delivering the worst yearly performance since the Credit Crisis. December alone delivered three quarters of the negative return in percentage terms. In technical terms the market has never been as oversold since the Credit Crisis as in December. Many investors wonder about the extent of this stock market reaction.

In our perception the main contributors to the weak investor sentiment are some fears that the Federal Reserve's tightening policy may be too aggressive, the continuing trade tariff uncertainties between the US and China, the US government shutdown, algorithmic trading activity and US taxpayers aggressively locking in losses at the end of the tax year. The combination of these clearly is fertile ground for further hedge fund activity.

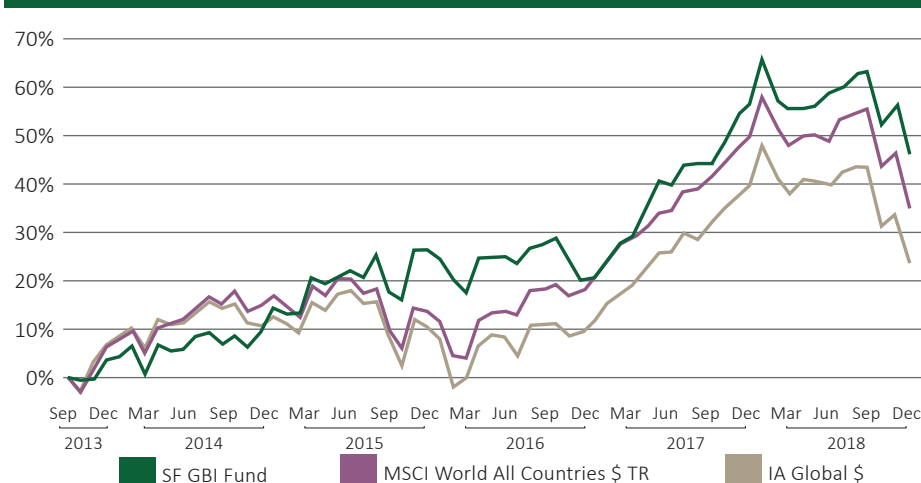
Leading economic indicators in the US have peaked recently, but do not yet provide signals of potential economic contraction in the near future. Indicators of China's manufacturing industry are currently less constructive, but the overall GDP growth this year is still expected to be around 6% (the absolute level of nominal growth in China's GDP is estimated to have exceeded the US's by about two thirds in 2018). World GDP is expected to grow in excess of 3% this year. Company profits are expected to continue to grow, though at a more moderate pace than in 2018. S&P 500 valuation levels have dropped to below average levels through the combination of higher earnings and lower share prices despite continuing moderate levels of inflation and interest rates.

Some of the tactical contributions to the current weak sentiment mentioned above can be addressed through negotiations and diplomacy. The Federal Reserve has little reason to be overly aggressive in further tightening this year. In the end, we believe the quality of the businesses in our portfolio, with their ability to keep growing their free cash flow, should allow for constructive fundamentals to again reassert themselves.

The Fund is a sub-fund of the Stonehage Fleming Pooled Investments (Ireland) plc (the "Company"), an open-ended umbrella investment company with variable capital and segregated liability between Funds incorporated with limited liability in Ireland under the Companies Act 2014 with registration number 525228. It qualifies and is authorised in Ireland by the Central Bank of Ireland as an Undertaking for Collective Investment in Transferable Securities ("UCITS").

The Company is recognised as a section 264 scheme by the Financial Conduct Authority in the United Kingdom. The Fund is an approved Foreign Collective Investment Scheme in South Africa where it is registered with the Financial Sector Conduct Authority (South Africa). The Fund has been granted consent pursuant to the Control of Borrowing (Jersey) Order 1958, by the Jersey Financial Services Commission ("JFSC") to circulate an offer for subscription,

sale or exchange of shares in Jersey. The JFSC is protected by the Control of Borrowing (Jersey) Law 1947, as amended, against liability arising from the discharge of its functions under that Law. Link Fund Administrators (Ireland) Limited has been appointed as the manager (the "Manager") of the Company and Stonehage Fleming Investment Management Limited has been appointed as the investment manager (the "Investment Manager") of the Company.
