COMMENTARY

Estée Lauder made it into our list of top ten holdings towards the end of last year. It is a high quality business and addresses our requirements for sustainable growth.

Estée and her husband Joseph founded the company in 1946 in New York and expanded the manufacturing and marketing of prestige skin care, make-up, fragrance and hair care products for the business to become a world leader in its category today. The family still has a 40% shareholding with voting and management control. Their excellent track record and the family's continuing commitment and involvement serve as a confidence booster for continuing success.

The beauty industry enjoys good growth potential, addressing an aspirational issue of consumers globally. In modern times every generation seems to have the potential to live longer than the previous one, with most of them trying to look and feel good doing so. With brands like Estée Lauder, Clinique, M-A-C, Aramis, Jo Malone, Bobby Brown, La Mer and Origins this business is particularly well placed to capitalise on mankind's vanity and ambitions for appearance.

The business has a ten year record of growing earnings at a compounded rate of +12% p.a. and dividends by +16% p.a. The balance sheet is lowly geared, with interest expenses today lower than in 2008, covered 27 times by earnings. It earns a return of 21% p.a. on all capital invested, whilst re-investments grow at +7% p.a. (over the past ten years), currently re-investing one third of free cash-flow. Over half of free cash-flow was last year utilised to buy back shares. The overall share-count decreased by -1.5% p.a. over the past nine years.

It is our impression that this business is well managed, in the interest of the family and its shareholders. We are happy to be able to share in the Lauder family's fortunes.
