COMMENTARY

We predominantly own businesses that operate globally and we also seek good exposure to emerging markets through developed market listings. This strategy provides us with the long term growth potential in the developing world's consumer markets especially, whilst being better protected against the higher volatility of shares listed in emerging markets. The portfolio has an effective one third look-through exposure to these markets.

Emerging market currencies and shares have suffered over recent quarters from the US Dollar's relentless strengthening. The resultant weak commodity prices have also had profound effects on many of these economies.

Whilst further Federal Reserve tightening may cushion the Dollar, it seems that its strengthening may have run most of its course (it is currently about 4% off its November 2015 peak). Many commodity prices seem to have turned the corner, with the possibility of some emerging market currencies to slowly follow suit. Should this trend continue, we may expect our businesses with larger emerging market exposure to re-rate over time against their developed market peers.

AB-Inbev has just received the South African Competition Commission's conditional approval to proceed with its acquisition of SABMiller Plc. The timing for the completion of this mega-deal later this year becomes interesting in the above context of hopefully better sentiment towards the global emerging market theme, along with the conclusion of its debt issuances to fund the acquisition probably at the very low end of interest rate levels.

Emerging market currencies are clearly not out of the woods yet, but the question is growing whether, in AB-Inbev, we may be witnessing the formation of the emerging market business of first choice for many developed market investors.
