

## STONEHAGE FLEMING GLOBAL BEST IDEAS EQUITY FUND

#### INVESTMENT OBJECTIVE

To achieve long term growth in capital and income in a focused portfolio of high quality listed businesses from around the world.

#### INVESTMENT PHILOSOPHY

We invest in best-of-breed businesses for their quality, strategic competitive edge and value.

#### INVESTMENT STRATEGY

- Invest for sustainable growth
- Fundamental research driven
- Particular focus on quality of management, balance sheet, return on capital, cash flow, ability to grow dividends each year
- Bottom-up approach to identify exceptional businesses
- Global orientation
- High conviction concentrated portfolio
- Predominantly larger capitalisation businesses, include some mid-size exceptional ones
- Buy to hold for longer term orientation, but do not hold overvalued businesses
- No benchmark orientation, leverage, hedging or active trading

#### COMMENTARY

We invest for sustainable growth in a business for it to be able to grow its free cash flow and then its dividend to shareholders each year with comfort, irrespective of the economic circumstance. Logically the business would need sustainable organic growth to be able to achieve this.

Whilst the technology sector is known for good organic growth, the main risk investors face in this sector is the possibility of technology advances making existing technologies obsolete. We have witnessed this especially in some hardware related businesses where a new device can replace a very popular one within a relatively short period.

We want to participate in the high growth delivered in this sector, but confine ourselves to its more durable software side. Technology is our second largest sector exposure, confirming our high expectation for these businesses.

One of the surest ways to monitor these businesses' sustainability is to relentlessly focus on every quarter's revenue growth. They all have long track records and already operate off a high base, and therefore will quickly show strain in revenue growth if the technology matures and starts to develop risk of becoming obsolete.

Accenture is our technology related business with the lowest growth (+8%) in dollar revenues with its last quarterly reporting. It experienced high growth (+30%) in cloud and cyber security services, which we believe can continue for long. Visa follows with +19% revenue growth, with continuing growth potential in global electronic payments. Alphabet (Google) surprised with +20% revenue growth, with more potential from the likes of Android and YouTube in its portfolio. Tencent announced +48% revenue growth, and seems to be the first technology business succeeding in combining social media and e-commerce in one business, creating further revenue growth potential.
