FUND OBJECTIVE

The objective of this portfolio is to provide above average growth in capital over the medium to long term. Income will be of secondary importance. The risk associated with this portfolio shall be the same as the risk associated with SA equities as an asset class. Volatility of capital can occur over the short-term.

FUND STRATEGY

The portfolio shall invest in assets in liquid form and in securities across all sectors of the JSE Securities Exchange of South Africa as well as international exchanges and other permissible assets allowed by the Act. The portfolio shall be allowed to invest in listed and unlisted financial instruments (derivatives) as allowed by the Act from time to time in order to achieve its investment objective, and shall be permitted to invest in offshore investments as legislation permits. This portfolio will invest predominantly in equities. Apart from the above, the portfolio may also invest in participatory interests of portfolios of collective investment schemes registered in the Republic of South Africa or of participatory interests in collective investment schemes.

The fund will be managed with a high conviction approach, typically holding no more than 20 positions at any time. In line with the investment manager's investment philosophy and process, the holdings will be concentrated in selected JSE Top 50 companies with the buy-to-hold management approach encouraging minimal portfolio turnover.

PORTFOLIO MANAGER MONTHLY COMMENT

2016 will likely be remembered as a year of the unexpected, with the outcome of the UK referendum and the US presidential elections taking investors by surprise. Domestically, politics and manoeuvring within the ruling party continued to dominate headlines with economic growth and consumer sentiment remaining lacklustre. The country managed to earn a reprieve from a downgrade to 'junk' by the rating agencies although this may prove to be temporary unless improved economic growth and political stability become evident in 2017. The JSE (and major global equity markets) had one of the worst starts to the year on record, as global recessionary fears and a slumping oil price weighed on markets. Although investor sentiment did improve over the year, equity markets remained extremely volatile with positive returns concentrated in certain sectors and companies.

The JSE All Share Index (with dividends included) managed to deliver a positive return of 2.6% for the calendar year. With dividends excluded, the All Share Index declined by 0.1%.

Looking ahead to 2017, whilst the US interest rate hiking cycle adds uncertainty, global interest rates look set to remain at historically low levels providing support for equity markets. The global rotation out of 'quality' companies (listed beverage, tobacco and consumer staple companies being great examples) into more cyclical sectors should normalize. The appeal of well managed companies at reasonable valuations that can consistently grow earnings and dividends will never fall away completely.

The SA economy could well have troughed in 2016, and coming off a low base, aided by improved commodity prices and moderating inflation we could well see a modest improvement in economic activity in 2017. In addition to the domestic economy, there are signs of improvement in the economies of a number of key emerging markets.

After the surprises and weakness experienced across a number of our core holdings in 2016, valuation levels are now at far more attractive levels than they were at the start of the year. Despite the ever-present known and unknown risks, looking ahead into 2017 we believe there is reason for a fair degree of optimism for portfolio returns.




