Objectives and Investment Policy

The objective and investment policy of the Fund aims to deliver total returns (inclusive of capital and income), generally over a period of 5 to 7 years, in excess of the FTSE All Share index through investment primarily in a diversified portfolio of UK securities in any economic sector. Equity exposure may be obtained through equity and equity linked securities including shares, depositary receipts, warrants and other participation rights, convertible securities, index and participation notes and equity linked notes. Its flexible investment approach means that the total return of the Fund may periodically diverge significantly from that of the FTSE All Share index. Derivatives and forward transactions may be used by the Fund for the purposes of hedging or Efficient Portfolio Management ("EPM") Purposes.

The Fund is a UCITS scheme as defined for the purposes of the FCA's Collective Investment Schemes Sourcebook as amended (the "Rules") and aims to invest primarily in equity securities, but in pursuing its objective it may also invest in other asset classes specified by the Rules and within the limits of the investment and borrowing powers prescribed by the Rules and the Fund's Prospectus. Derivative and forward transactions may be used by the Fund. Subject to the Fund's objective, policies and investment powers, it allows the Manager to make discretionary choices when deciding which investments should be held in the Fund.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income units. Investors can buy and sell units on demand when the scheme prices daily at 10.30 pm.


