### Objectives and Investment Policy

The objective and investment policy of the Fund is to achieve capital growth and an element of income.

The Fund will generally only invest in Units in other regulated collective investment schemes. The Fund's assets will be invested predominantly in UK and international regulated equity funds. There may be some use of derivatives for Efficient Portfolio Management. In seeking to meet the investment objective, a portion of the Fund's property may be invested in units or shares of collective investment schemes managed or operated by the Investment Manager or an associate of the Investment Manager.

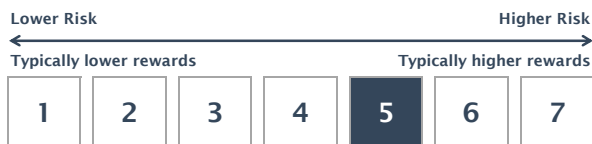
The Investment Manager reviews, on an ongoing basis, the objectives of the underlying funds into which the Investment Manager invest the Fund and they consider their appropriateness against their asset allocation views and assessment of manager skill.

The Fund is a non-UCITS retail scheme ("NURS") as defined for the purposes of the FCA's Collective Investment Schemes Sourcebook as amended (the "Rules") and may also invest in other asset classes specified by the Rules and within the limits of the investment and borrowing powers prescribed by the Rules and the Prospectus. Derivative and forward transactions may be used by the Fund. Subject to the Fund's objective, policies and investment powers, it allows the Investment Manager to make discretionary choices when deciding which investments should be held in the Fund.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income units. Investors can buy and sell units on demand when the scheme prices daily at 10.30 pm.

### Risk and Reward Profile



The risk rating of the Fund is category 5 due to the volatility of the Fund price which sits in a range of between 10% and 15%. The risk rating is calculated using historical data and a prescribed standard deviation methodology.

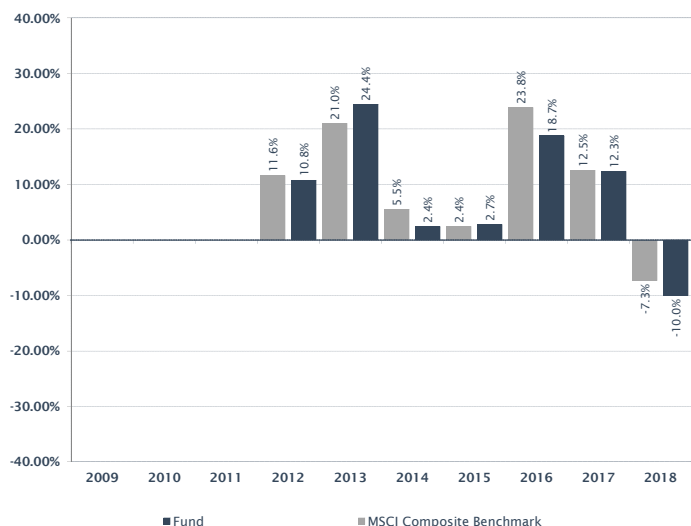
The entry and exit charges shown are maximum figures. In some cases you might pay less - you can find this out from your financial adviser.
